In Pennsylvania alone Trump's legal counsel Rudy Giuliani had testimony of 50-60 poll watchers who claimed being deprived of an ability to inspect mail in ballots.

Nationally, noted attorney Sydney Powell said, "Hammer and Scorecard – the NSA Security Software turned illegal Election Software – ran an algorithm that gave Biden a 3% vote advantage in Wisconsin, Michigan, Pennsylvania, Georgia, Nevada and Arizona."
