**Foster Parent Bonuses:** In 2026, NYAP and agencies like Journey Home offer "sign-on" or "referral" bonuses (ranging from \$500 to \$2,000) to recruit new foster parents. However, these are often one-time payments compared to the permanent \$200+ per-day administrative fee the agency keeps.

**In Guernsey County Ohio**, commissioners recently moved forward with Resolution 26-23, a desperate attempt to levy new taxes on local residents. The reason? The cost of placing children in foster care has skyrocketed. Leading the list of vendors is the National Youth Advocate Program (NYAP), a "non-profit" whose CEO, Marvena Twigg, earns a staggering \$1.89 million annually.

While Guernsey County pays NYAP up to \$300 a day for a single therapeutic bed, NYAP is simultaneously pulling from a \$121 million federal pot for its "La Jornada" program. - **They provide the "Journey Home"** program which focuses on intensive recruitment of parents in the Zanesville area.
- **Because NYAP holds the massive federal contracts**, they often use smaller agencies like Journey Home to "fill the beds" when their own homes are at capacity.
- **The result is a shared "pipeline"** where a foster home in Zanesville may house a local child one month and a migrant youth the next, while the millions in "admin fees" flow upward to Columbus.
