



Quotes from William Alexander's speech on April 13, 2026 in the US form the basis for the Act of Abjuration 2

The Act of Abjuration of 1581 came about to stop tyranny and oppression and to establish the Netherlands as an independent sovereign republic.

The Act marks the birth of the Republic of the United Netherlands by rejecting a totalitarian reign of terror by the Spanish occupier under Philip II, as a foreign power.

This statement was widely reported in Pennsylvania and explained by King Willem Alexander, where we as a population have been made aware that we, the population, are superior to the government according to Willem Alexander, his own statement.

King Willem Alexander who is not recognized by everyone as a rightful king among the suffering population.

Since the WEF has infiltrated evil into the royal family and politics, according to the statement of Klaus Swab and CBDC proponent Queen Maxima, and support of Willem Alexander who pretends to be king, who acts against the interests of the population, and through his NGO Crime card of politics continuously betraying the population, an Act of Abjuration 2 is now in place.

It is the great Fiat money deception of Banks, FED, ECB and central Banks, Multinationals and business that governs, they drive politics through the judiciary as Commercial Law the population from within the NGO governed Netherlands Private Company company, has betrayed its own population, Genocide has been carried out by unleashing the Covid19 Bio Weapons on the population.

This was made possible by declaring people dead and creating a fictitious Legal Entity for them to comply with commercial law, so laws are made appropriate to be able to dominate and oppress through the PERSONA as a Legal Persona, so that people do not want to and cannot recognize Man within the current legal system.

The Judges act as trustees of the birth trust of the legal person because man has no voice in the judiciary.

This will have to be corrected on the basis of birthright or customary law.

Now on to the crime of GENOCIDE by Bio-weapon vaccinations that the government has committed against the population.

Getting rid of the excess mortality in the figures and replacing their own population with 3rd world population, this is treason at the highest level.

Then the question arises, who was the beneficiary of collecting birth trust from the murdered population?

King Willem Alexander, together with his wife, Maxima, is no better than the late **Nicolae Ceaușescu, of Romania** and co-responsible and active participation, human trafficking, Genocide of her own population, with as proof her own input in a WEF meeting with Klaus Swab, to use the CBDC with the coercion of a digital ID, to be able to check people whether they have taken the lethal injection.

One of the co-executors in addition to Mark Rutte and Hugo de Jonge was Ernst Kuipers who stated on screen that the data of the Vaccination were not yet known because it was a medical experiment, which is prohibited by the Geneva Convention and the Nuremberg Code tribunals apply.

 - Each of the 1949 Conventions was added to Article 3 which prescribes the necessary principles that parties must adhere to in a non-international armed conflict. Article 3 is the same in every treaty.

We as a population do not recognize ourselves living in peace, freedom, and prosperity, partly caused by the whole Globalist system of WEF and Banks, with their Fiat money deception.

The betrayal of the Royal Family during the 2nd World War by fleeing the country together with the government on May 13, 1940, meant that the Kingdom from that moment on lapsed together with the constitution, this Constitution which was a contract, with the monarchy and promise to guarantee the population a fair and legal framework for justice.

Willem Alexander admitted this betrayal at the commemoration of the dead in 2020 in The Hague, apologizing for fleeing his great-grandmother Queen Wilhelmina, only he had not mentioned that Article 21 of the Constitution in force at the time had been violated, taking into account the expiration of this constitution and the kingship.

After all, the Constitution was a contract of the monarchy with the population of the royal family, and has therefore expired and is therefore no longer valid as of May 13, 1940.

On May 18, 1940, on the orders of Adolf Hitler, a new government installed by the Nazis, unelected, only assigned traitor positions to NSB to bring the country under their control and to govern it in favor of the occupier, the Nazis.

That is why Mayors are not elected by the people, but appointed by the NGO Nazis on the basis of their loyalty at the expense of the population.

As a result, it has been possible for Mayors to set up test and vaccination centers to facilitate the GENOCIDE in their own municipality throughout the country on behalf of the NGO WEF Crime cartel of politics and Government.

When the German occupier ended and capitulated to the Nazis, a peace treaty was never concluded with the occupier, the government of the country was never returned to the population, hence the statement that we are still ruled by Nazis.

This was also not possible as the Occupier had been replaced by the Allied forces, as the victor of World War 2, which is why the US is now responsible for this, and must help us the population to regain our freedom as Sovereign residents of the Republic of the Netherlands.

The King is guilty of human trafficking, and has this enforced on the population for the corrupt invalid legal system, which is no different from the oppression by the Spaniards before 1581.

The unsuspecting population has been kept ignorant in order to maintain the power of the NGO rulers, where Willem Alexander known in Pennsylvania that they must serve the rulers, the people, which has not happened since May 13, 1940.

We have experienced servitude as oppression and coercion, to maintain the imposed corrupt corporate structure, to send Police to the population and to have them abused by Police violence in the name of the King.

People are expropriated daily with a writ of execution through Bailiff and justice in the name of the King.

This means that confidence in the monarchy has fallen far below zero.

The ludicrous actions of King Willem Alexander mean that we the people are now obliged to draw up a new act of abandonment in order to abolish the corrupt monarchy and restore the republic to order.

As mentioned by Willem Alexander in Pennsylvania, and the restoration of the Constitution of 1776, this is the reason for us to adopt the restored Constitution of the US of 1776 in the absence of our own valid constitution, law and regulations, which Willem Alexander agreed to, whereby he in fact resigns and announced his own resignation and this must be ratified through a new act of abolition.

We also demand a constitutional court to prevent abuses in the future.

We, the people of occupied and oppressed Netherlands, request the Postmasters, in cooperation with the administration of Donald J Trump, to draw up a new Act of Abjuration under the implementation of EO13818 and the RICO act and to try the responsible oppressors through military tribunals.

We, the people and heir of the territory of the Republic of the Netherlands, declare that all contracts and treaties entered into by the NGO government from May 13, 1940 are null and void on a national and international level, as the drafters of these treaties were not authorized to do so on behalf of the dissolved Netherlands, and Kingdom as a company.

We the sovereign population are not bound by treaties of the Kingdom of the Netherlands BV, whereby the EU, UN, NATO, WHO, Migration pacts in any form are invalid.

All treaties from before May 13, 1940 must be revised, such as the treaty of Rome and Vienna.

We demand the abolition of the entire control and coercion apparatus that has been established by the NGO government since May 13, 1940.

The Senate and House of Representatives should be dissolved, including the corrupt judiciary that had become knowledge bearers and should have commissioned the Public Prosecution Service to investigate the Genocide from February 10, 2022, and did not apply Article 162 of the Criminal Procedure, which they were obliged to do as knowledge bearers of the crime and could have stopped the Genocide immediately, This is more like negligence, but an act of active complicity.

All 40 people who form a WEF shadow government of NGO Netherlands and appear in the Jeffrey Epstein files must be arrested and tried.

All public service employees, including the police, tax authorities, municipality and province, are dismissed, with the possibility to reapply if proven to be suitable and loyal to the population under oath and after a screening about their actions and performance of work in the past.

The Police who are under the delusion that they represent the strong arm of the law and have applied violence to the population can never again get a job in the public interest within the republic of the Netherlands.

All residents of the Republic of the Netherlands should be compensated by paying out their birth trust, and an unconditional basic income with a **restriction** of individuals who have committed crimes against the population on behalf of the NGO government and the royal family, and multinationals.

All residents with a migration background including their descendants of migrants, within a time frame of the past 45 years, must have their birth trust paid in the country of origin, the trip back to their own country of origin and culture is paid for them from the new government or country government.

A new national government will have to be elected within a period of 120 days from the introduction of GESARA, from a select group of people who have the qualities and integrity, and have made themselves available in an open vacancy to be posted.

In the bridging period, the army will have to maintain order and ensure a safe transition.

These new State administrators and newly appointed Judges through common law will receive an income on the basis of an employment contract, whereby they must be replaced immediately from abuse, from their position, in order to prevent corruption in the future.

Since international law is above national law, this declaration will have to be presented and ratified at the ICC in The Hague.
