**To report someone being held unlawfully** or without legal cause in Southern Ohio, you should immediately petition for a **Writ of Habeas Corpus** through the local court system and report the unlawful detention to the [Ohio Bureau of Criminal Investigation](#) or federal authorities. [1]

**Reporting an unlawful jailing in Ohio** involves taking both immediate legal action and administrative steps:

**1. File a Petition** for a Writ of Habeas Corpus (Immediate Release)

A **writ of habeas corpus** is the primary legal mechanism to force an agency to justify why an individual is incarcerated. [1]

- **Where to file:** You can file this petition in the [Court of Common Pleas](#) in the county where the person is currently being held, the District Court of Appeals, or the Supreme Court of Ohio. [1, 2]

- **Action:** Review the Ohio Public Defender Habeas Petition Packet for the exact forms and instructions required to challenge unlawful imprisonment pro se. [1]

## 2. Report Civil Rights Violations

**If the unlawful detention involves an abuse of power,** misconduct by law enforcement, or a violation of constitutional rights: [1]

- **Federal Level:** Submit an online report directly to the [Department of Justice Civil Rights Division](#) or your local FBI Field Office.
- **State Level:** File a public corruption or law enforcement misconduct tip with the Ohio Attorney General's Bureau of Criminal Investigation. [1, 2]

## 3. Report Agency Misconduct

**If the unlawful jailing is the result of abuse,** misconduct, or wrongful acts by specific jail staff, corrections officers, or police:

- **File a formal grievance** or contact the Internal Affairs division of the specific detaining agency (e.g., the local County Sheriff's Office or local Police Department). [1, 2]
- **For statewide oversight,** you can submit a complaint to the [Ohio Inspector General](#) for investigations into wrongful acts or omissions by state agencies. [1]
