Judy Note: This past week the Cabal's attempt to trigger a fake global escalation in the Middle East completely backfired. Instead of starting a war to save their assets, they handed Trump the exact legal justification needed to activate absolute Military Law.

The upcoming unavoidable stock market, housing market and commercial real estate market crashes were now set to destroy the Global Financial System. In anticipation of that startling global event, Trump and the Global Military Alliance triggered the below as per Web 3.0 ISO20022 and Tier4b ISO20022 on Telegram:

At exactly 4:12 PM Eastern on Fri. 19 June 2026 the central routing servers for the old SWIFT banking system in Manassas, Virginia, suffered a "technical anomaly" that dropped their processing capacity to zero for 18 minutes. The White Hat Alliance had executed the final data mirror.
