Judy Note: In 1898 Nikola Tesla built the first Med Bed. It used high-frequency oscillating currents to penetrate human tissue without contact. No wires touching the body. No chemicals. No surgery. It increased cellular energy production, destroyed pathogenic organisms without harming healthy tissue, accelerated wound healing by 300% and restored neurological function in damaged nerves.

He understood in 1898 what modern quantum biology is only now confirming — that the human body is an electromagnetic system, and disease is a frequency problem, not a chemical one.

After Tesla’s death in 1943, the FBI seized 80 trunks of his documents. The Office of Alien Property — a wartime agency with no medical jurisdiction — classified everything. His electrotherapeutic research was never released to the public. They buried it for 128 years.

The same year, penicillin entered mass production. The pharmaceutical era officially began. Tesla’s frequency-based approach was buried beneath a trillion-dollar chemical industry that needed you to believe healing required their products.

128 years later, the technology Tesla envisioned is not only real — it is operational. The MedBed network uses the same foundational principles he discovered: coherent electromagnetic fields calibrated to the human body’s natural resonant frequency.

Before 1910, doctors in America were healing with frequencies, light, sound, and electromagnetic fields. Not as “alternative” medicine. As mainstream medicine. It was taught in universities. It was practiced in hospitals. It was working.

Then one report changed everything. The Flexner Report. Funded by the Rockefeller Foundation. Published in 1910. Its stated goal was to “standardize” medical education. Its real goal was to eliminate every form of healing that could not be patented and sold in a bottle.

Within 15 years, over 160 medical schools were shut down. Homeopathy — gone. Naturopathy — gone. Electrotherapy — gone. Every doctor who refused to prescribe chemicals lost their license. Every researcher who studied frequency-based

healing lost their funding.

What replaced it? A pharmaceutical delivery system disguised as healthcare. A system where the patient is never cured — only managed. Where every diagnosis leads to a prescription. Where every prescription leads to a side effect. Where every side effect leads to another prescription.

By 1934 Dr. Royal Raymond Rife had built a machine that destroyed cancer cells using only frequency. No radiation. No chemicals. No surgery. A 100% cure rate in terminal patients. This was front-page news in the San Diego Tribune, **1934**. They killed Rife.

In 1938, a German biophysicist named Dr. Erwin Neher discovered that Human blood is not just a transport fluid. It is a piezoelectric crystalline structure — meaning it generates electrical charge in response to mechanical pressure and electromagnetic frequency. Your blood is a living antenna.

This discovery was immediately classified by the Third Reich and placed under the jurisdiction of the Ahnenerbe — the SS division responsible for weaponizing suppressed science. After the war, Operation Paperclip transferred 1,600 German scientists to the United States. Neher's blood-crystal research went directly into a black-budget program at Fort Detrick, Maryland — the same facility that later developed biological weapons. The research continued in secret for 85 years.

The elite have been using Med Beds since the 1950s. Why was this technology hidden for over 70 years? If the people knew about Med Beds, everything collapses. Big Pharma makes \$2 trillion per year selling poison to the body. Hospitals make trillions just in the treatment of age-related diseases.

Since 1956 and for 70 years, the FDA has protected Big Pharma and lied to the American people. The FDA is not a health agency. The FDA is a PHARMACEUTICAL CARTEL PROTECTOR.

In 1974, German biophysicist Fritz-Albert Popp proved that every living cell emits a faint but continuous stream of light. He called them biophotons. This is not a metaphor. It is measurable photon emission from your DNA. Biophotons were the basis for Med Bed therapy.

By 1978, the Kaznacheyev Laboratory had built a device called the "Mir" (Peace) — a full-body chamber that emitted corrective biophotonic frequencies to restore cellular communication. It was the first Med Bed. It restores the light. It floods your cellular network with the correct biophotonic frequencies. **Since 1991**, versions of "Mir" technology have been operational in Underground military medical facilities (USA, UK, Israel).

Page 25 of a CIA Document "Analysis and Assessment of Gateway Process" invalidated the entire foundation of modern medicine: "The human body is not a biochemical machine. It is a coherent electromagnetic field that generates and sustains physical matter."

The CIA study confirmed that the human body can be rebuilt — from the frequency level up — without a single chemical, surgery, or pharmaceutical intervention. The Med Bed restores the frequency. The body does the rest. The document was declassified in **2003**, but the technique was never released to the public.

Between June and September 2015, twelve holistic doctors were found dead across the United States. All twelve were researching the same molecule: GcMAF (Glycoprotein Macrophage Activating Factor), a protein that your body naturally produces that activates your immune system to destroy cancer cells.

In 2019, an internal email was sent to every licensed physician in the American Medical Association network. 847,000 doctors received it. The subject line read: "Updated Clinical Guidelines: Non-Pharmaceutical Electromagnetic Interventions — Position Statement"

The email contained one directive: "Any physician who recommends, prescribes, endorses, or refers patients to electromagnetic frequency-based therapy will face immediate license revocation, removal from insurance networks, and potential criminal liability under state medical practice statutes."

Buried in paragraph 14 — the paragraph no one reads — was this sentence: "The AMA acknowledges that peer-reviewed evidence supports the biological efficacy of PEMF therapy in tissue regeneration, pain management, and immune modulation. However, widespread adoption would destabilize existing treatment revenue models and insurance reimbursement structures."

On Wed. 15 July 2026 at 4:00 am EST President Trump signed Executive Order 2026-1947, which declassified Med Bed technology for civilian use. A 3,400-page classified report had documented 61 years of suppressed frequency healing research on Med Bed technology. It proved that Med Bed treatments could reverse aging, detox cells, activate stem cells, rewire nervous systems and naturally regenerate organs including heart, liver and kidneys.

The EO prohibited the FDA from interfering with Med Bed distribution, while pharmaceutical companies had until **Oct. 15 2026** to disclose all suppressed clinical trials involving frequency-based treatments — or face criminal prosecution under 18 U.S.C. § 1001. The EO was signed at 4am EST and by 5:30 am pharmaceutical lobbyists had called CNN, NBC and ABC telling them not to run the story - which they didn't. On Sat. 18 July 2026, the Walter Reed nurse's testimony confirmed that Med Beds regrew legs on 847 amputee soldiers in 4-6 days, fully restored 312 brain injury cases, healed 94 spinal cord warriors to walk in 14 days and cured 1,200 cancers at 100 percent remission. Generals wives and senators daughters received instant 35 minute cures while 600,000 Americans died of cancer in 2023.

In 2019 the American Medical Association (WHO) sent an internal email to every licensed physician in America - 847,000 doctors: The email acknowledged the positive effects of Electromagnetic therapy (Med Beds), but threatened the doctors with loss of license and criminal prosecution if they used it because of the financial affects it would have on the medical, insurance and pharmaceutical industries.

Since 2014, I have personally administered chemotherapy to 847 children. I know — with absolute certainty — that at least 70% of them could have been cured in 75 minutes with zero pain.

Instead, I gave them 6-18 months of chemical torture. I watched their hair fall out. I watched them vomit until they had nothing left. I watched their parents sell their homes to pay for treatment that I KNEW was inferior to technology that already existed.

This letter is not enough. Nothing will ever be enough. But the silence ends today."

Zh. Update Kaitlynn Hunter, Jeannine Larrick

Jeannine Larrick has been released from the Guernsey County Jail, though still faces charges of Obstruction of Justice for harboring her abused daughter Kaitlynn. “Currently Judge Williams has stricken all my discovery and filings from the record and is demanding I go to District 9 again and take another competency evaluation before she will hear the case. The same entity who said I suspected Rico and did not trust the government that helped strip custody in 2021. Now there is a warrant for my 5th arrest on an unconstitutional order to continue the narrative for 7 long years.”
